Commissioner Bobby Miller moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to set ad valorem millage rates for the 2014-2015 tax year.

Commissioner Jerry Tingle moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to approve a funding request of \$30,095.17 from the District 2 Discretionary Fund to the City of Tuscaloosa Water and Sewer Department to provide for the extension of water service and the setting of meters for the residents on Mountain Brook Lane, Cottdale.

Commissioner Jerry Tingle moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a funding request of \$12,340.62 from the District 2 Discretionary Fund to PARA for the Abernant Park fencing.

Commissioner Bobby Miller moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a funding request of \$19,200.00 from the District 3 Discretionary Fund to the Englewood Hills Volunteer Fire Department to update their equipment.

Commissioner Reginald Murray moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to approve a funding request of \$34,726.00 from the District 4 Discretionary Fund to Sipsey Valley High School for bleachers.
