This being the date and hour to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge W. Hardy McCollum presiding as Chairman. The following members were present:

Commissioner Bobby Miller moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to levy county license fees for alcoholic beverages for fiscal year 2015-2016 in the amounts shown in the exhibit as attached.

Commissioner Stan Acker moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to authorize payment of invoices to Walker Associates and Neel-Schaffer Almon for engineering services on the following ATRIP projects:

Commissioner Stan Acker moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to adopt a resolution approving and accepting the preliminary plat submission for Evelyn Banks Subdivision Lot 1 in District 2.

Commissioner Stan Acker moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to approve a Subdivision Regulation Waiver Request to Morgan's Landing in District 1.

Upon recommendation by County Attorney, Robert Spence, and upon motion by Commissioner Bobby Miller, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to accept Murphy's Place Subdivision Phase I and II in District 3.

Commissioner Jerry Tingle moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to adopt a resolution authorizing the vacation of right-of-way of a portion of Dream Lake Road. A public hearing was held February 18, 2015 and no persons were in attendance to object.

Commissioner Bobby Miller moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to grant a 60 day extension to West Alabama Bank to bid for and demolish 11318 Athena Drive.

Commissioner Bobby Miller moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to adopt resolutions authorizing the demolition of the following properties determined to be public nuisances:

Commissioner Reginald Murray moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to go into Executive Session prior to the end of this meeting to discuss board appointments.

Commissioner Stan Acker's motion to provide funding in the amount of \$30,000.00 to PARA for lights on the Miracle League ball field from the District 1 Discretionary fund was seconded by Commissioner Bobby Miller. Commissioner Reginald Murray made a motion to amend to add \$5,000.00 from the District 4 Discretionary Fund to decrease the funding from District 1. Commissioners Jerry Tingle and Bobby Miller also added \$5,000.00 from their respective Discretionary Funds to decrease the funding from District 1. The motion to amend to provide \$15,000.00 from District 1 and \$5,000.00 from Districts 2, 3, and 4 for a total of \$30,000.00 to PARA for the Miracle League field lights was accepted by Commissioner Stan Acker and approved unanimously.

Commissioner Jerry Tingle moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to begin the condemnation process of structures of the properties:

Commissioner Reginald Murray moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve a funding request of \$2,000.00 from the District 4 Discretionary Fund to PARA for surveying for the land acquisition for Braughton Park.
