This being the date and hour to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge W. Hardy McCollum presiding as Chairman. The following members were present:

Commissioner Bobby Miller moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to change the following County Commission Meeting dates:

June 17, 2015 to June 24, 2015 July 1, 2015 to July 8, 2015

Commissioner Bobby Miller moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to extend the demolition of 11318 Athena Drive, Tuscaloosa, AL 35405 for 30 days. Demolition notice was posted on the structure on May 12, 2015 making the revised demolition date to be June 12, 2015.

Commissioner Stan Acker moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to authorize payment of invoices to Burk-Kleinpeter for engineering services on the following projects:

Union Chapel Road & Watermelon Road intersection upgrade project \$3,500.00

Holman Church Road bridge replacement project \$2,500.00

Engineering services on FEMA approved projects from the April 2014 storm event \$33,900.00

Commissioner Reginald Murray moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to support a resolution presented by Mr. Gary Limmroth of Tuscaloosa Citizens against Predatory Practices (T-CAPP) on lowering the interest rates of payday and title loans.

Commissioner Jerry Tingle moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve the Engineering Department to develop a three year plan to address completion and acceptance of the remaining delinquent subdivisions.

Commissioner Jerry Tingle moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to approve a funding request in the amount of \$2,957.00 from the District 2 Discretionary Fund to PARA for a swing set at Abernant Park.

Commissioner Jerry Tingle's motion, seconded by Commissioner Reginald Murray, to implement an addition half (1/2) cent school sales tax for a period of 84 months failed on a two-two tie vote. Commissioner Stan Acker and Commissioner Bobby Miller cast the NAY votes.

Commissioner Stan Acker moved, seconded by Commissioner Bobby Miller, the County Commission voted unanimously to go into Executive Session prior to the end of this meeting to discuss a board appointment.

The Commission retired into Executive Session.

Following Executive Session, Chairman W. Hardy McCollum called the Commission back to order.

Commissioner Bobby Miller moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to appoint Curtis Travis to the PARA Board. This term is set to expire October 1, 2016.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, June 3, 2015.
