Commissioner Bobby Miller moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to authorize payment of invoices to Burk-Kleinpeter, Almon Associates, McGiffert and Associates and Indian Creek Excavating, LLC for the following projects:
