This being the date and hour to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge W. Hardy McCollum presiding as Chairman. The following members were present:

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the warrants issued to cover Tuscaloosa County's expenditures for February 2013.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to adopt a resolution authorizing the vacation of a right-of-way of an unnamed public alley off Woodland Drive and Woodland Lake Development. Davis.

The motion to table passed on a three-to-one vote with Commissioner Stan Acker casting the NAY vote.

Commissioner Jerry Tingle moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to adopt a resolution approving revisions to the Tuscaloosa County Subdivision Regulations and approved the form of the request as attached.

Commissioner Bobby Miller moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to depart from the order of business set forth in the official agenda to discuss the disposition of the Tuscaloosa County Board of Education building.

Commissioner Bobby Miller moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to deed the present Tuscaloosa County Board of Education downtown property to the Tuscaloosa County Board of Education to dispose of it as they see fit and use the proceeds on the new building that they received from the U.S. Government, (the old Federal Courthouse Building). After discussion, Commissioner Bobby Miller moved, seconded by Commissioner Stan Acker, to amend the motion to allow the Tuscaloosa County Board of Education to dispose of the present building and property and Tuscaloosa County Commission execute the deeds on the disposition. The amended motion passed unanimously.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, March 27, 2013.
