This being the date and hour to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge W. Hardy McCollum presiding as Chairman. The following members were present:

Commissioner Reginald Murray moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to authorize payment of invoices to Burk-Kleinpeter for engineering services on the following projects:

FEMA projects from April 28, 2014 tornadoes  
(Heritage Road, Old Jug Factory Road, and Main  
Street NE Retaining Wall Repair) \$16,765.00

Holman Church Road bridge replacement project  
\$1,000.00

Old Fayette Road over Binion Creek tributary bridge  
replacement project \$2,000.00

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to authorize payment in the amount of \$55,756.79 to the City of Tuscaloosa for resurfacing the County's portion of Hargrove Road and Virginia Drive.

Commissioner Reginald Murray moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to authorize payment in the amount of \$6,512.40 to Foster-Ralph Water Authority for reimbursement of engineering costs associated with the waterline relocation on the Nixon Road construction project.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to accept streets in Oak Creek Phase I subdivision for maintenance.

The County Commission unanimously approved the warrants issued to cover Tuscaloosa County's expenditures for September 2014.

Commissioner Stan Acker moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to adopt a resolution authorizing the termination of a temporary construction easement, and quitclaims of said easement to the Tuscaloosa County Industrial Development Authority.

Commissioner Stan Acker moved, seconded by Commissioner Reginald Murray, to amend the 2014-2015 fiscal year budget by reallocating \$500,000.00 from the "Transfer Out to Construction Projects" line and assigning \$75,000.00 in the District Development Fund for each district (totaling \$300,000.00), \$100,000.00 to the District Attorney's Office, \$50,000.00 to the Volunteer Firefighter's Association to upgrade their communications system, \$25,000.00 to the Tuscaloosa Symphony Orchestra, and \$25,000.00 to Family and Children's Education

Services. After discussion, Commissioner Reginald Murray withdrew his second and suggested the motion be discussed at the next scheduled meeting after Chief Financial Officer Bill Lamb has reconciled the 2013-2014 fiscal year budget.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, November 5, 2014.
