- 5. The prospective lower tier participant agrees by submitting this proposal that, should the proposed covered transaction be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department or agency with this transaction originated.
- 6. The prospective lower tier participant further agrees by submitting this proposal that it will include the clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion Lower Tier Covered Transaction," without modification, in all lower covered transactions and in all solicitations for lower tier covered transactions.

RESOLUTION AND ORDER

A RESOLUTION AND ORDER CONFIRMING AND RATIFYING THE LEVY OF THE COUNTYWIDE SCHOOL SALES TAX IN TUSCALOOSA COUNTY

BE IT RESOLVED AND ORDERED by the Tuscaloosa County Commission (herein called "the Commission"), the governing body of Tuscaloosa County (herein called "the County"), as follows:

Section 1. Findings. The Commission hereby finds and declares that there is levied in the County, pursuant to Section 40-12-4 of the Code of Alabama 1975, as amended, and a resolution of the Commission adopted on April 6, 2005, as supplemented and amended on January 7, 2009, and on November 4, 2009, a special privilege license or excise tax (herein called "the Sales Tax"), the proceeds of which are allocated and apportioned between the two boards of education in the County; and that the Tuscaloosa County Board of Education (herein called "the Board") proposes (a) to issue its Capital Outlay Warrants, Series 2011, in the approximate principal amount of \$48,000,000 (herein called "the Warrants"), for the purpose of providing various capital public school improvements, and (b) to pledge, for the payment of the principal of and interest on the Warrants, that portion of the proceeds of the Sales Tax presently being allocated, apportioned and paid to the Board.

Section 2. <u>Pledge</u>. The County hereby pledges, to the Board and to the registered owners of the Warrants, the Board's allocated or apportioned share of the Sales Tax and agrees that it shall continue to levy and provide for the collection of the Sales Tax until the final retirement of the Warrants not later than July 1, 2016.

RESOLUTION OF THE TUSCALOOSA COUNTY COMMISSION SUPPORTING A REFERENDUM ON SUNDAY ALCOHOL SALES

WHEREAS, the Alabama Legislature has authorized the sale of alcoholic beverages within the municipal limits of the City of Tuscaloosa on Sundays, following a referendum by the citizens of the City of Tuscaloosa; and

WHEREAS, several retailers outside of the City of Tuscaloosa have begun the process of annexation into the City of Tuscaloosa for the purpose of being allowed to sell alcoholic beverages on Sunday; and

WHEREAS, Tuscaloosa County faces the loss of revenue from those retail stores that successfully annex into the City of Tuscaloosa.

NOW, THEREFORE, BE IT RESOLVED by the Tuscaloosa County Commission, as follows:

The Tuscaloosa County Commission urges the local legislative delegation to introduce and pass legislation that will allow a referendum by the voters in Tuscaloosa County to permit Sunday alcohol sales throughout the county.
