Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a funding request in the amount of \$10,000.00 from the District III Community Development funds to Duncanville Middle School for the baseball field improvements and new backstop netting.
