This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve the minutes of November 11, 2021.

Chairman Rob Robertson presented Tuscaloosa County Engineering Department Coker Camp Superintendent Jeff Swindle a twenty-five year service pin and thanked him for his dedicated service to the citizens of Tuscaloosa County.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to assign the remaining District II American Rescue Plan Act funds from the Warrior River Water Board, who voted to not move forward with their water projects, to Vance Elementary Water Main Moving Project (Citizens Water).

Commissioner Reginald Murray moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to depart from the order of business set forth in the official agenda to discuss a work session item.

Commissioner Reginald Murray's motion to have regular work sessions to address County hiring practices was seconded by Commissioner Jerry Tingle. After discussion, an amendment to the motion was offered and accepted to add the topic to the next work session. The County Commission voted unanimously to approve the motion as amended.
