This being the date and hour to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the minutes of November 20, 2019.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to table the preliminary plat submission and waiver request for Chase Landing in District III.

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve a funding request in the amount of \$4,500.00 from the District I development fund to Northside High School for the purchase of uniforms and equipment for the 2019-2020 girl's golf team.

Commissioner Stan Acker moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a funding request in the amount of \$7,000.00, to be divided equally between each district development fund (\$1,750.00 each), for the Tuscaloosa County 4H Robotics Program.


Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve a funding request in the amount of \$5,000.00 from the District II development fund to the Town of Vance for red rock for ballfields.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a purchase and sale agreement between The Alabama Community College System and The Tuscaloosa County Commission regarding property located on 35th Street, adjacent to the Tuscaloosa County Road and Bridge Department, for use by the Sheriff's Office.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to depart from the order of business set forth in the official agenda to discuss funding to Sipsey Valley High School.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve a funding request in the amount of \$2,200.00 from the District IV development fund to Sipsey Valley High School girl's basketball for the purchase of uniforms.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, December 18, 2019.



Commissioner - District I


