Commissioner Bobby Miller moved, seconded by Commissioner Gary Youngblood, the County Commission voted unanimously authorize the demolition of structures qualified by FEMA as listed on the attached exhibit.






There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, January 4, 2012.






