This being the hour and date to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge W. Hardy McCollum presiding as Chairman. The following members were present:

The County Commission set February 1, 2001, as the deadline for tornado victims to place tornado debris on the public rights-of-way. Debris placed on the public rights-of-way will be removed by the contractor hired to remove said tornado debris left by the December 16, 2000, tornado.

Commissioner Bobby Miller moved, seconded by Commissioner Gary Youngblood, the County Commission voted unanimously to change line items in the Sheriff's Office budget as outlined in the attached exhibit. This is being done to facilitate the cost of reducing the number of salary steps from eighteen to twelve for employees in the Sheriff's Office without increasing the Sheriff's budget. Some line items were reduced to cover any additional cost.





RE: Property Transfer/Juvenile Probation Officers

Enclosed is an inventory list of all property reported on a survey to this office as property to be transferred to the State that is being used primarily by juvenile probation officers in your county. Please review the inventory list and note the following:

- 1) In accordance to ACT #98-392, automobiles cannot be transferred to the State.
- 2) Telephones are to be maintained by the county, and consequently, cannot be transferred to the State.
- 3) Any type of restraining equipment used by law enforcement officers (i.e., leg irons, handcuffs, etc.) cannot be transferred to the State since it should not be utilized in the operations of juvenile probation officers.
- 4) Computer software will not be tagged because it is a betterment to a personal computer system.
- 5) Copiers that are currently under a lease/purchase agreement between the county and a vendor will not be tagged.

Excluding the above exceptions, all remaining property on the inventory list can be transferred to the State. The Administrative Office of Courts (AOC) will not tag any property that has a purchase price of less than \$100.00 even though it is being transferred to the State.

In accordance to the Act, the county commission should review the attached inventory list and return it to the AOC within sixty days after receiving it. Once the inventory list has been returned to this office, a date will be scheduled with the juvenile judge and/or chief probation officer to have property being transferred tagged by the AOC Property Manager.

Dear Sheriff Sexton:

The Tuscaloosa County Sheriff Department has been selected to receive a traffic enforcement grant of Fifteen Thousand Dollars. Enforcement objectives will be realized through funding of overtime salary + fringe to state and local enforcement agencies to implement a comprehensive traffic safety program with a focus on statistic data contributing to crashes by implementing stationary, mobile (DUI), speed, safety belt, and child restraint enforcement programs.

Traffic enforcement programs coupled with intense community education and an awareness campaign has been found to be the most effective combination to reduce the number of traffic crashes, injuries and fatalities in a defined region. The West Alabama Traffic Safety Program Project will be used as a supplement to regular basis.

West Alabama Traffic Safety Program and The Tuscaloosa County Sheriff Department, hereafter referred to as AGENCY, for 100% funded salary plus allowable fringe overtime traffic enforcement and traffic safety education funds not to exceed \$15,000.00, enter into this agreement.

This funding is made available under the Alabama Department of Economic and Community Affairs, (ADECA) 01SP-PT-005 Project.

Agency agrees to comply with all documentation procedures as outlined in the Attached A before reimbursement will be made by West Alabama Traffic Safety's Director.

The AGENCY agrees to appoint a traffic coordinator and alternates from their law enforcement department. This person will be responsible for submitting required documentation of overtime hours, required documentation of overtime hours, required reporting to West Alabama Traffic Director of overall project within their department.

All reimbursement statement, contact reports, and supporting documentation must be submitted to West Alabama Traffic Safety Director, on or before, the 15th of the month following the month of activities. Automatic suspension of funds, until documentation is received, will occur for those departments not meeting this deadline.

The Enforcement Committee will meet monthly beginning October 30, 2000, on the last day of the month at 10:00 A.M. at location chosen by West Alabama Traffic Safety's Director. If this day should fall on a weekend, the meeting will be held the Friday preceding the weekend at the same time and place. The enforcement committee may adjust this meeting.

The AGENCY agrees to send the appointed and the alternate to all the West Alabama Traffic Safety Director's enforcement committee meetings held under this project.

The AGENCY agrees to conduct quarterly observational safety belt surveys, within their jurisdiction, counting a minimum of 100 vehicles at five (5) separate locations per survey. The first survey will be completed by December 15, 200, and done quarterly throughout the life of the project. Completed surveys will be submitted to West Alabama Traffic Safety's Director along with that month's reimbursement statement.

The AGENCY will coordinate traffic safety activities to coincide with but not limited to the five (5) major holidays: Memorial Day, Fourth of July Day, Labor Day, Thanksgiving Day, Christmas Day, and National Drunk and Drug Driving Week in December.

The AGENCY agrees to maintain an average of two (2) written contacts per hour, excluding educational material and verbal contacts, throughout the life of the project. These contacts may be written warnings and/or citations. Extenuating circumstances will be reviewed by the enforcement committee for approval.

The AGENCY agrees to use budgeted funds for selective enforcement activities surrounding six (6) time periods during the year which include the three (3) major summer holidays, 3D prevention month in December, Child Passenger Awareness Month in February and All-American Buckle-up Month in May. The AGENCY agrees to use a minimum of 25% of their budgeted funds for traffic safety education programs and documentation as outlined in Attachment A.

The AGENCY is solely responsible for the acts and omission of its employees and agents. This agreement does establish an agency relationship between the Agency and West Alabama Traffic Safety Director. To the extent permitted bylaw, the Agency shall defend indemnify and hold harmless West Alabama Traffic Safety Director from all claims and demands for personal injury or death and property damages arising from the performance of this agreement by the Agency, its agents and employees, including expense, attorney fees, compensatory or punitive damages, claims, demands, actions, amounts, and costs incurred by the West Alabama Traffic Safety Director in the investigation and defense of such claims.

The AGENCY agrees to comply with all other requirements as outlined by West Alabama Traffic Safety Director which are needed to carry out the scope and intent of this project in accord with the Agreement entered into between West Alabama Traffic Safety Director and the State of Alabama Department of Economic Community Affairs, and the Law Enforcement Traffic Safety Division, as amended from time to time.

West Alabama Traffic Safety Director agrees to reimburse the AGENCY for actual traffic safety enforcement and education overtime worked under this project, provided the overtime is documented and spent in accordance with attachments A and approved by Enforcement and Education Committee Chairperson.

The AGENCY agrees to appoint a traffic coordinator and alternates from their law enforcement department. This person will be responsible for submitting required documentation of overtime hours, required documentation of overtime hours, required reporting to West Alabama Traffic Director of overall project within their department.

All reimbursement statement, contact reports, and supporting documentation must be submitted to West Alabama Traffic Safety Director, on or before, the 15th of the month following the month of activities. Automatic suspension of funds, until documentation is received, will occur for those departments not meeting this deadline.

The Enforcement Committee will meet monthly beginning October 30, 2000, on the last day of the month at 10:00 A.M. at location chosen by West Alabama Traffic Safety's Director. If this day should fall on a weekend, the meeting will be held the Friday preceding the weekend at the same time and place. The enforcement committee may adjust this meeting.

The AGENCY agrees to send the appointed and the alternate to all the West Alabama Traffic Safety Director's enforcement committee meetings held under this project.

The AGENCY agrees to conduct quarterly observational safety belt surveys, within their jurisdiction, counting a minimum of 100 vehicles at five (5) separate locations per survey. The first survey will be completed by December 15, 2000, and done quarterly throughout the life of the project. Completed surveys will be submitted to West Alabama Traffic Safety's Director along with that month's reimbursement statement.

The AGENCY will coordinate traffic safety activities to coincide with but not limited to the five (5) major holidays: Memorial Day, Fourth of July Day, Labor Day, Thanksgiving Day, Christmas Day, and National Drunk and Drug Driving Week in December.

The AGENCY agrees to maintain an average of two (2) written contacts per hour, excluding educational material and verbal contacts, throughout the life of the project. These contacts may be written warnings and/or citations. Extenuating circumstances will be reviewed by the enforcement committee for approval.

The AGENCY agrees to use budgeted funds for selective enforcement activities surrounding six (6) time periods during the year which include the three (3) major summer holidays, 3D prevention month in December, Child Passenger Awareness Month in February and All-American Buckle-up Month in May. The AGENCY agrees to use a minimum of 25% of their budgeted funds for traffic safety education programs and documentation as outlined in Attachment A.

The AGENCY is solely responsible for the acts and omission of its employees and agents. This agreement does establish an agency relationship between the Agency and West Alabama Traffic Safety Director. To the extent permitted bylaw, the Agency shall defend indemnify and hold harmless West Alabama Traffic Safety Director from all claims and demands for personal injury or death and property damages arising from the performance of this agreement by the Agency, its agents and employees, including expense, attorney fees, compensatory or punitive damages, claims, demands, actions, amounts, and costs incurred by the West Alabama Traffic Safety Director in the investigation and defense of such claims.

The AGENCY agrees to comply with all other requirements as outlined by West Alabama Traffic Safety Director which are needed to carry out the scope and intent of this project in accord with the Agreement entered into between West Alabama Traffic Safety Director and the State of Alabama Department of Economic Community Affairs, and the Law Enforcement Traffic Safety Division, as amended from time to time.

West Alabama Traffic Safety Director agrees to reimburse the AGENCY for actual traffic safety enforcement and education overtime worked under this project, provided the overtime is documented and spent in accordance with attachments A and approved by Enforcement and Education Committee Chairperson.

Adjustments in funding level; time period or scope of this agreement may only be accomplished through written amendment to this agreement upon recommendation of the Enforcement Committee and approved by the Executive Committee.

Dear Mr. Chairman and Members of the Commission:

Attached you will find copies of a new proposed subdivision to be located at the end of McPherson Landing Road (District 3). The name of the subdivision will be **River Point Subdivision**. Jason Robertson is the owner of the property with Apodaca Engineering, Inc. being the land surveyor.

This subdivision as depicted, proposes to use existing roads that were constructed for use in a private mobile home park. The homes have been removed and repairs to the existing roads are underway. The existing roads currently are 27 feet in width and have 30" valley gutter. The entrance road only has valley gutter around lots 1 and 18. The entrance road was constructed by Tuscaloosa County forces and is currently in good shape. No additional work should be needed for this road.

Apodaca Engineering is requesting a waiver for the current subdivision regulations for the following items:

- 1) Maximum 600' cul-de-sac length. (As proposed, the cul-de-sac will be approximately 770'+/-)
- 2) Minimum lot size that adjoins a 50' right-of-way without curbing. (Currently, a road with a right-of-way of 50' must have lots that are 1.0 acres in size or larger) Lot 19 is 0.25 acres in size. Lots 1 & 18 have curbing.
- 3) Sidewalks construction (They are requesting that they be allowed to place the construction of the sidewalk in the performance bond along with the final wearing surface. They wish to construct the sidewalks after the housing construction has taken place so that the sidewalks will not be destroyed.

The current subdivision regulations require that the sidewalks be constructed before the plat is to be signed by this department. The proposed construction sequence does not meet these requirements.

The roads (as shown) have been constructed and have been used as a private mobile home park. All the mobile homes have been removed and it is our wish to restore this area into a subdivision suitable for permanent housing.

We are requesting three (3) waivers from the current subdivision regulations so that we may continue with the construction of this subdivision.

- 1) Cul-de-sac length (will exceed the 600 maximum length).
- 2) Minimum lot size requirements (No. 19) for a road with a 50' wide right-of-way and without curb and gutter. (Current regulations specify that lots must be 1.0 acre(s) in size – minimum for this type of road). Valley gutter exists in front of all lots with the exception of Lot 19. The entrance road does not have curb and gutter from the railroad to said Lot 19. This road was constructed by County forces several years ago and is in very good shape.
- 3) The sidewalk requirement for "Neighborhood Subdivisions, Section 5-4-14." As per this section, sidewalks must be installed before the plat is to be signed. It is our wish to construct these sidewalks during the "performance bond" period so that the construction of the houses will not destroy the new sidewalks. We would like to place the construction of the sidewalks along with the final wearing surface of asphalt in the performance bond. Sidewalks will be completed before the final inspection of the subdivision.
