Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the minutes of October 5, 2022.

Commissioner Jerry Tingle moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve updates to the County Travel Policy and County Vehicle Use Policy.

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to begin condemnation proceedings on 3420 Pine Crest Dr, District II.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve funding in the amount of \$9,600.00 from the District II discretionary fund to Citizen's Water for the Ridge Road water meter project to the sixteen (16) addresses attached as an exhibit. This is to place meters for the homes listed to connect to Citizen's Water. The owners will have approximately one (1) year to connect under the agreement.

to Public Works to assist the Town of Vance on the Evergreen Church Road improvement project.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to depart from the order of business set forth in the official agenda to consider an executive session.

Commissioner Reginald Murray moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss a board appointment.

The Commission retired into Executive Session and did not reconvene.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, November 2, 2022.
