This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve the minutes of January 11, 2023.

Chairman Rob Robertson read into the record and presented to Mr. Dennis Duncan a proclamation proclaiming February 2023, as "CAREER AND TECHNICAL EDUCATION MONTH."

Commissioner Reginald Murray moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss contract negotiation and pending/on-going litigation.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to adopt a resolution approving and accepting the preliminary plat submission for Wicker Estates, Section One, District I.

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve bid award for the Tuscaloosa County Jail Commissary bid to Kimble's Food by Design for three (3) years at a Commission rate of 52.5%, as present by Chief Loyd Baker.

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve District III community development funding in the amount of \$1723.36 to JMCM Consulting as a match to a Firefighters Grant for Englewood Hulls VFD.

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve three (3) District III discretionary fund expenditures of \$5,690.00 each for the purchase of a thermal camera and MSA Altair Gas Monitor for Englewood Hulls VFD, Duncanville VFD, and Hagler VFD.

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve District III ARPA funding in the amount of \$211,915.47 for the North Rosser Road water main relocation project with Englewood Hulls Water System.

The Commission retired into Executive Session and did not reconvene.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, February 1, 2023.
