This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the minutes of June 21, 2023.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve an American Rescue Plan Act (ARPA) allocation in the amount of \$225,000.00 for a Holt Affordable Senior Housing project, contingent upon grant approval.

Commissioner Mark C. Nelson's motion to approve an appropriation in the amount of \$175,000.00 from the District III ARPA fund to Community Services of West Alabama for the renovation of the Vineyard Building was seconded by Commissioner Stan Acker. The motion passed unanimously with Commissioner Jerry Tingle recusing himself due to being a Community Services board member.

Commissioner Mark C. Nelson's motion to approve an appropriation in the amount of \$75,000.00 from the District III ARPA fund to Community Services of West Alabama for the Glen Revitalization Initiative was seconded by Commissioner Stan Acker. The motion passed unanimously with Commissioner Jerry Tingle recusing himself due to being a Community Services board member.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to adopt a resolution approving and accepting the preliminary plat submission for Crossland Parker Subdivision, resurvey of lot 1, District I.

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to remove the following properties from the Public Nuisance/Demolition list:
