This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve the minutes of March 22, 2023.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss contract negotiations, pending litigation, and board appointments.

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to amend the County's Deferred Compensation plan to include offering the John Hancock 457b plan to current employees.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to grant a 60-day request for extension of demolition on 684 Union Chapel Rd, District I.

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to award the bid for oil change services on County vehicles to Speedy Oil Change, the lowest bidder meeting specification, as recommended by Lt. Jeff Judd.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve a District I community development fund expenditure in the amount of \$17,017.50 to Tuscaloosa County High School as the second and final installment of the new headset package.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve a District II community development fund expenditure in the amount of \$228.00 to Public Works for two (2) 50 ft. Rolls of 4 ft. chain link wire for Abernant Ballfield.

Commissioner Jerry Tingle moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a District II community development fund expenditure in the amount of \$9,000.00 to the Brookwood High School football program for equipment.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a District III community development expenditure in the amount of \$15,434.00 to Hillcrest High School for band instruments.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to submit application for the ALDOT Sidewalk Grant to extend the Oakdale Sidewalk Project to Joe Mallisham Pkwy.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to depart from the order of business set forth in the official agenda to consider funding for tables at the Fosters Farmer's Market.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve a District IV community development expenditure of \$4,000.00, with \$2,500.00 to the County Maintenance Department to purchase materials and \$1,500.00 to the Tuscaloosa County High School carpentry class to build 20 tables for the Fosters Farmer's Market.

The Commission retired into Executive Session and did not reconvene.
