Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve a change order deduction in the amount of \$39,986.00 on the Culver Road Sanitary Sewer Project, pending acceptance of the change by the City of Tuscaloosa.
