This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve the minutes of May 21, 2025.

Commissioner Reginald Murray moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to go into an executive session prior to the end of this meeting to discuss personnel policy matters.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to change the regularly scheduled County Commission Meetings as follows:

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve GIS support for Visual Address Management for Voter Registration in the amount of \$10,200.00.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to fix the cost of demolition and file a lien in the amount of \$11,222.20 on 17586 Hwy 43N, District I, and remove the property from the Public Nuisance /Demolition list.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a District III community development funding request in the amount of \$2,416.62 for the Englewood/Hillcrest Fast Pitch Softball Field light repair project.

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to adopt a personnel management policy pertaining to non-exempt employees, with work in progress on a policy to address exempt employees.
