## TUSCALOOSA COUNTY COMMISSION MEETING

August 27, 2025

This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Stan Acker Jerry Tingle Mark C. Nelson Reginald Murray

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve the minutes of August 6, 2025.

Commissioner Stan Acker moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to reappoint Commissioner Jerry Tingle to the Association of County Commissions of Alabama Legislative Committee.

Commissioner Jerry Tingle moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to consider approval for cost sharing of the SEEDS grant project in the amount of \$125,000.00.

Commissioner Reginald Murray moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss Economic Development Matters.

Judge Rob Robertson read the Resolution for the Dedication of the Mr. and Mrs. Leroy McAbee, Sr. Bridge into record.

Commissioner Stan Acker moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a request from Scott Anders, County Engineer, regarding a preliminary plat submission of the Wesley Stepan Subdivision.

Commissioner Stan Acker moved, seconded by Commissioner Reginald Murray to approve Greymont Phase Three and the waiver request for open space. The Commission was addressed by Cam Parsons who expressed concerns primarily over lot sizes, especially lot width. Assistant Engineer Tracy Criss explained that lot width under the applicable regulations is measured at the building set-back line, not the street frontage. The Commission was addressed by Audra Kirkland who expressed concerns over the impact of additional residences on schools and requested the item be tabled to discuss reconfiguring the entrance to minimize direct impacts to her residence. The Commission was addressed by Jesse Harris who expressed concerns over flooding issues in neighboring Ridge Haven. The Commission was addressed by Monroe Payne, president of the Greymont homeowner's association, who expressed concerns primarily on the impact of Phase Three on the values of the homes in previous phases of the Greymont subdivision. After discussion, Commissioner Stan Acker withdrew his motion regarding Greymont Phase Three. Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, to table these requests to allow further discussion. The motion to table passed unanimously.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve a Subdivision Plat Waiver Request for Lot 10 Thomson Place:

- 1. Resurvey of a portion of Lot 10 Thomson Place
- 2. Waiver of lot size to be served by a private easement

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to authorize the execution of a "Road Usage Agreement" with Warrior Met Mining Operations. This agreement includes Brandon School Road, Wallace Ferry Road and Blackburn Road in Tuscaloosa County. The waiver requested is:

- 1. Extended Weight Haulage up to 126,000 gross vehicle weight along the designated truck haulage route.
- 2. Warrior Met Mining partnership with Tuscaloosa County for continued and mutual road maintenance.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve the warrants issued to cover Tuscaloosa County's expenditures in the amount of \$8,637,237.37 for July 2025.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to fix the cost of demolition and file a lien in the amount of \$8,263.09 on 12405 Fosters Loop Rd., District IV, and remove the property from the Public Nuisance/Demolition list.

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to authorize CMH to accept bids for the first phase of the Courthouse renovation project.

The Commission was addressed by Tricia Willmon and Roderick Foster regarding the future of Abernant Ballpark and for guidance on how to manage the facility. At the request of the Commission, Tricia Willmon and Roderick Foster spoke with Jay Logan, PARA representative, who provided directions on how to schedule use of the facility and requested the Commission for light signage for anyone requesting to use the Abernant Ballpark.

The Commission was addressed by Thomas Sahm with Animal Welfare Collaborative regarding drainage infrastructure at the Metro Animal Shelter. Commissioner Acker stated design work has been done to improve the drainage system. The next stage is trying to find an economical way for the work to be completed. Mr. Sahm was invited to attend a Metro Animal Shelter board meeting where representatives from all three governments will be available.

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve a District I community development funding request in the amount of \$4,500.00 for the Tuscaloosa County High School weight room project.

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously close Arborway Circle

under section 11-3-10 of the Code of Alabama, at a location to be determined in the sole discretion of the County Engineer before it crosses into the Tuscaloosa City Limits

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a District III community development funding request in the amount of \$34,000.00 for Hillcrest High School Digital Signs and displays in the gym for advertisements and class meetings.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to approve a District III community development funding request in the amount of \$20,421.28 to Hillcrest High School for Digital clocks and a Satellite Clock System.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted three (3) to one (1), opposed by Commissioner Stan Acker, to approve Sales Tax Equalization under ACT 1994-535 and for the proceeds to be used for infrastructure and capital improvement projects.

Commissioner Reginald Murray moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve a District IV community development funding request in the approximate amount of \$34,000.00 for site work and concrete slab to Romulus Volunteer Fire Department.

The Commission was addressed by Rev. James Williams, Dr. Chad L. Jackson, and Ms. Donna Wilson Stadmire of Tuscaloosa County Chapter of the Southern Christian Leadership Conference (SCLC) regarding the support of the Commission and Sheriff's Department for their partnership and commitment to the upcoming Community Safety & Law Enforcement Forum on Monday, September 8, 2025.

The Commission was addressed by Freddie Mullenix regarding road conditions of Holt Peterson Rd. Tracy Criss will look at short-term measures for Holt Peterson Rd. and the possibility of putting additional signage on the narrow road until a long-term goal can be achieved.

The Commission retired into Executive Session.

Following Executive Session, Chairman Ward D. "Rob" Robertson called the Commission back to order.

Commissioner Mark C. Nelson moved, seconded by Commissioner

Jerry Tingle, the County Commission voted unanimously to suspend the
rules and depart from the order of business set forth in the official
agenda to discuss three items:

- 1. Economic Development Project
- 2. Traffic Study agreement
- 3. Synergic Center emergency repairs

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve an economic development incentive request for Project Stratum between Tuscaloosa County and the town of Vance.

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to develop an agreement for a collaborative traffic study from exit 97 to exit 100 which will be paid for by multiple partnerships.

Commissioner Jerry Tingle moved, seconded by Stan Acker, the County Commission voted unanimously to move forward with emergency repairs to the Synergic Center Uninterrupted Power Supply (UPS) System due to the system failing and causing critical infrastructure security issues.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, September 3, 2025.
