This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve the minutes of October 15, 2025.

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss Economic Development Projects, Economic Development Authority (EDA) Appointment and Litigation.

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to adopt five (5) updated Personnel Policies:

The Commission was addressed by Jerry Turner regarding the condition of Yellow Creek Church Road. Commissioner Stan Acker advised repairs on the road are still in process and is scheduled for asphalt this fall.

The Commission retired into Executive Session.

Following Executive Session, Chairman Ward D. "Rob" Roberston called the Commission back to order.

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to appoint Bruce Higginbotham to the Tuscaloosa County Industrial Development Authority (dba Tuscaloosa County Economic Development Authority) to serve out the remainder of the late Gary Nichols term. The term will expire November 13, 2028.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, November 19, 2025.
