This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve the minutes of November 19, 2025.

Commissioner Jerry Tingle moved, seconded by Commission Mark C. Nelson, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss personnel matters.

Commissioner Jerry Tingle moved, seconded by Commission Mark C. Nelson, the County Commission voted unanimously to approve a Resolution amending elements in the Civil Service Act of Tuscaloosa County from 1949 to comply with Family Medical and Leave Act (FMLA) and The Affordable Care Act.
