This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the minutes of January 7, 2026.

The following preliminary subdivision was presented to the County Commission by Scott Anders, County Engineer, for Review:

1. Resurvey of Lot 1 Barbed Wire Estates 2, District I

After discussion and comments from the public, Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, to deny the following two waiver requests. The motion passed unanimously:

1. Cottage Hill, District I
2. Resurvey of Lot 1 Nutters Run, District I

After discussion, Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, to table the following road name change requests. The motion passed unanimously:

Commissioner Stan Acker moved, seconded by Commissioner Jerry Tingle, the County Commission unanimously approved to authorize advertising for bids on the USDA CDS - Samantha Multi-Use Governmental Service Center as presented by Grants Administrator, Lauren Benson.

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the request for a professional services contract for billboard valuation/auditing with Avila Engineering Group (AED) as presented by Tax Assessor Leigh Ann Fair. The basic amount covers 233 structures at approximately \$95,000.00; any additional billboards will be billed at \$410.00 per billboard.

Commissioner Mark C. Nelson moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve a funding request of \$9,800.00 to Tuscaloosa County Sheriff's Office for the Student Resource Officer Conference in June 2026 from District III Community Development Funds.

The County Commission was addressed by Patricia Harris regarding if a road by her residence on Harryman Drive in Brookwood, AL is a private road or a County maintained road. Ms. Harris was referred to speak with County Engineer, Scott Anders.

The County Commission was addressed by Loretta Griffin and Willie Bowden regarding safety of children on a Tuscaloosa County School Bus being dropped off at houses on Hwy 82 East in Duncanville, AL. Judge Robertson explained Hwy 82 E is a State maintained road not a county-maintained road. They were referred to ALDOT. It was noted, Commissioner Mark C. Nelson will speak with the school about changing bus locations.

The County Commission was addressed by Ms. Brenda Shaw regarding property located at 1021 38<sup>th</sup> Avenue NE. County Commissioner Jerry Tingle advised Ms. Shaw the house will be condemned if the major structural issues such as the roof are not repaired.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday February 4, 2026.
